ORDER

Whereas, the Rashtriya Sanskrit Sansthan (Deemed University), Ekalavya Campus, Old IASE Building, P.O.- Kunjaban, Near Buddha Mandir, Radha Nagar, Agartala, Tripura- 799006 (Code No. ERCAPP1728) was granted recognition for Shiksha Shastri (B.Ed.) course of one year duration with an annual intake of 100 students vide ERC's order no. ERC/7-164.6.15/NCTE/Shiksha Shastri./2013/22100 dt 30.11.2013 from the academic session 2014-2015.

- 2. And whereas, a Revised Recognition Order (RRO) was issued to the institution vide order no. ERC/NCTE/ERCAPP1728/Shiksha Shastri (B.Ed.)(Revised Order)/2015/32521 dt. 30.05.2015 for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 50 (One basic unit) from the academic session 2015-2016 as per the NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.
- 3. And whereas, the ERC in its 275th (Part-2) meeting held 27th July, 2019 considered the matter and decided as follows:-

"Ist show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 19.06.2019 and the institution is still deficient on the following grounds:-

- (i) Approved faculty list is not submitted in NCTE prescribed proforma.
- (ii) As mentioned in the letter dated 09.07.2019, four contractual teacher are not accepted as per Norms.
- (iii) Building plan and building completion certificate are not submitted.

Recognition granted to Shiksha Shastri - B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

Accordingly, recognition granted to the institution has been withdrawn u/s 17(1) vide order no. F.No.ER-275.14.85/ERCAPP1728/B.Ed./ 2019/61435 dt. 28.08.2019 from the academic session 2020-2021.

- 4. And whereas, the institution preferred an appeal at the NCTE Hqrs. against the withdrawal order dt. 28.08.2019 and the Appellate Authority vide order no.89-423/E-139550/2019 Appeal/9th Mtg.-2020/28th February, 2020/91510 dt. 15.07.2020 remanded back the case to the ERC for revisiting the matter.
- 5. And whereas, the ERC in its 283^{rd} meeting held on $24^{th}-25^{th}$ August, 2020 considered the reply dt. 09.08.2020 & 06.08.2020 submitted by the institution alongwith the appeal order dt. 15.07.2020, the original file & other related documents in light of the NCTE Act, 1993, NCTE Regulations, Guidelines issued by the NCTE from time to time and decided as under:-

And whereas, the ERC in its 284th meeting held on 17th – 18th September, 2020 reviewed the matter and decided as under:-

Now therefore, recognition of the institution withdrawn vide order dt. 28.08.2019 has been restored alongwith change of name of the institution from Rashtriya Sanskrit Sansthan (Deemed University) to Central Sanskrit University, Ekalavya Campus, Old IASE Building, Kunjaban, Near Buddha Mandir, Radha Nagar, Agartala, Tripura - 799006 (Code No. ERCAPP1728) for conducting Shiksha Shastri (B.Ed.) course of two years duration with an annual intake of 50 students (one unit).
