NOTIFICATION

In exercise of the powers conferred by the provision of Section-135B(1) of the Representation of the people Act, 1951, in connection with the ensuing General Election to Village Committees under TTAADC, 2026, Tripura schedule to be held on 28th September 2026, the Hon'ble Governor of Tripura is pleased to declare that:

1. All Government Offices, Magisterial Courts, Financial Institutions and all other Establishments falling within the jurisdiction of the village committees under the TTAADC where General Election is going to be held, shall remain closed on 28th September, 2026.
2. Every person employed in Government establishments, in any business, trade, industrial undertaking or any other establishments, entitled to vote at the General Election to VCs under TTAADC, shall be granted a paid holiday on the day of poll.
3. There may be cases where a person is ordinarily a resident of the constituency concerned and is registered as an elector, may be serving/employed in Government Establishment or an industrial undertaking or an establishment located outside the constituency concerned including casual/daily wages workers working outside the constituency concerned where General Election to VCs under TTAADC is going to be held, shall be entitled to the benefit of a paid holiday on the day of poll.

This shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.
